Ming was previously a Partner at CCMP Capital Asia (formerly J.P. Morgan Partners Asia), where he was responsible for investments in the automotive, consumer and industrial sectors in Korea, China, Japan, Australia and Southeast Asia.

Prior to joining JPMP Asia in 1999, Ming was President of Asia Pacific at Lucas Varity, a leading global automotive component supplier. He also worked for Kraft Foods International Inc. and CITIC, the largest direct investment firm in China.
