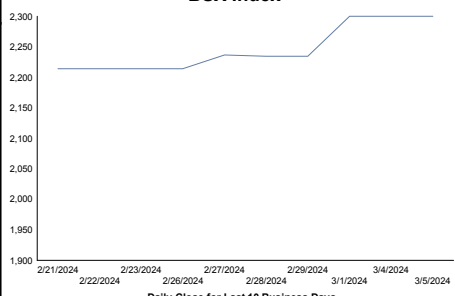

Yield Yield is the current dividend or interest a stock or bond will earn, with the yield expressed as a percentage of the amount paid for the security or of the security's par value.														
Mkt Cap Market Capitalisation is determined by multiplying the number of outstanding shares by the current market price.
