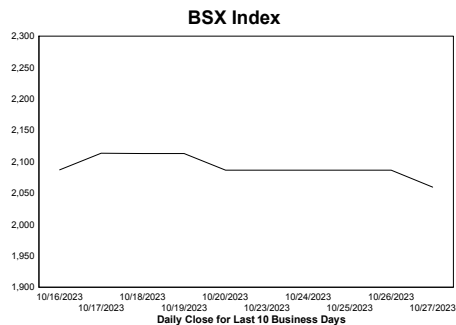
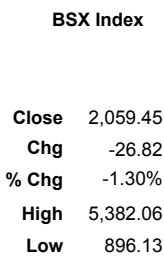

Market Capitalisation is determined by multiplying the number of outstanding shares by the current
